SOME OF OUR 2021 PROGRAMS INCLUDED: RHABDO TRAINING. RHABDOMYOLYSIS IS A SERIOUS, SOMETIMES LIFE-THREATENING CONDITION THAT CAN BEGIN UNNOTICED AS A CONSEQUENCE OF PROLONGED OVEREXERTION THAT CAN PROGRESS RAPIDLY TO RENAL FAILURE AND EVEN DEATH. THE FRCE DEVELOPED AWARENESS MATERIALS FOR WILDLAND FIREFIGHTERS REGARDING THE PREVALENCE, IMPACT, PREVENTION, RECOGNITION, AND TREATMENT. THE FRCE DEVELOPED ADDITIONAL RESOURCES TO ASSIST FIRE DEPARTMENT CHAPLAINS WITH MENTAL HEALTH AND RESILIENCE AS WELL AS ADDITIONAL RESOURCES FOR FIRE DEPARTMENT BEHAVIORAL HEALTH PROGRAMS.
